AN ORDINANCE OF EAST ROCKHILL TOWNSHIP, BUCKS COUNTY, AMENDING SECTION 15-201(1) OF THE EAST ROCKHILL TOWNSHIP CODE OF ORDINANCES AND ESTABLISHING A SPEED LIMIT OF 25 MILES PER HOUR FOR MOTOR VEHICLES ON NORTH ROCKHILL ROAD FROM THE BRIDGE OVER THE RAILROAD TRACKS TO ITS INTERSECTION WITH OLD BETHLEHEM PIKE.

#### **Preamble**

The East Rockhill Township Board of Supervisors, upon the recommendation of the Township Engineer and the Township Roadmaster, and pursuant to the appropriate engineering and traffic studies where necessary and the Pennsylvania Vehicle Code, hereby enacts and ordains as follows:

#### ARTICLE I.

Words and phrases used in this Ordinance shall have the meaning ascribed to them in the Pennsylvania Vehicle Code, 1976, June 17, P.L. 162, Act No. 81, as amended ("Pennsylvania Vehicle Code").

## ARTICLE II.

Chapter 15, Part 2, Section 201, Maximum Speed Limits Established on Certain Streets, Subsection 1 (§15-201(1)), of the East Rockhill Township Code of Ordinances is hereby amended by the addition of the following maximum speed limit along North Rockhill Road in East Rockhill Township:

Street	<u>Between</u>	Maximum Speed Limit
North Rockhill Road	Bridge over railroad tracks to Old Bethlehem Pike	25 mph

#### ARTICLE III.

The proper authorities of the Township are directed to erect official signs establishing a maximum speed limit of twenty-five (25) miles per hour along the above-referenced section of North Rockhill Road and to do so in conformity with the provisions of the Pennsylvania Vehicle Code and this Ordinance.

### ARTICLE IV.

Repealer. All ordinances, parts of ordinances, and amendments thereof are hereby repealed insofar as they are inconsistent with this Ordinance.

#### ARTICLE V.

Severability. If any section, paragraph, sub-section, clause or provision of this Ordinance shall be declared invalid or unconstitutional by a court of competent jurisdiction, such decision shall not affect the validity of this Ordinance as a whole or any part thereof other than that portion specifically declared invalid.

# ARTICLE VI.

Effective Date. This Ordinance shall be	ecome effective five (5) days after final enactment.
