**Park & Recreation Rules & Regulations:**

- A. Permit holder and Users agree to abide by all Rules and Regulations cited in Code of Ordinance §16-103.
- B. Permit holder is responsible for the removal of all decorations, trash and recycling from the park generated from the event as a courtesy to following groups. If the park was left in unsatisfactory condition upon your arrival, notify the Township immediately by voice mail or email to ensure the security deposit is returned.
- C. Permit holder is responsible to bring their own trash bags.
- D. Permit holder is required to have the approved permit with them when using a park facility where such a permit is required.
- E. Organized Sport Association (youth and adult), must submit an Insurance Certificate naming East Rockhill Township as an additional insured party.
- F. Moon bounces and other inflatable devices are prohibited.
- G. No alcoholic beverages are permitted on Township property.
- H. Animals must be kept on a leash.
- I. Use of amplified music is prohibited.
- J. Parking in spots designated for golf driving range patrons or on grass areas is prohibited. Additional parking is available in the rear of the Willard H. Markey Centennial Park.
- K. East Rockhill township shall not be held responsible for any injury sustained by any individual during the course of recreational activities taking place.
- L. A security deposit is required by a separate check. To have the check returned, a self-addressed stamped envelope (SASE) must accompany this application. If a SASE is not received the check will be destroyed upon completion of the activity(s) and adherence to the rules and regulations. The liability for damage incurred by the Applicant is not limited to the amount of this deposit fund.
- M. Approved park use permits are issued via electronic mail to the responsible party.

Security Deposit Refundable if:

- No littered trash and/or food around grounds reserved.
- No damage to structure (including stapling / tacking of posters or signs), furnishings and fields.
- User leaves the premises in as good or better condition than which existed prior to their usage.
- User has followed all the Park Rules & Regulations.
- All equipment has been returned in good order.
- The deposit is to be returned at the discretion of the East Rockhill Township Manager.
